Standard booth size 15x15 will be \$100.00 and \$90.00 for non-profits. These will include water and electricity if needed. If you need additional space, it will be \$10.00 per foot in length.

Booth spaces will be sold on a first-come-first-serve basis determined by date of application AND money received. You must pay in full to guarantee your spot. There is no guarantee that there will not be other items like yours being sold, please prepare for this. Booth setup will start at 12:00pm on Thursday July 25<sup>th</sup>. There will be no unloading or pulling into the parking lot after 8:00am Friday July 26<sup>th</sup>. Be prepared to carry your stuff across the park. **NO PULLING ONTO THE GRASS!!** There are sprinklers that can be damaged.

No one is allowed in the parking lot without Mancos Days permission. If you need to pull into the parking lot, please contact the Mancos Days Vendor contact first. There is NO PARKING in any parking lot or at the back side of the park. Unload, move your car then go setup.

## VENDOR REGULATIONS AND INFORMATION

**Event hours:** Friday 10:00am-8:00pm, Saturday 8:00am-8:00pm, Sunday 8:00am-12:00pm

\*Booth spaces are sold on a first come first sold basis by date application received

\*You will be notified of acceptance

\*No refunds for inclement weather or vendor cancel.

\*All food vendors must be approved by the Montezuma County Health Department and have proper forms. Montezuma County Health Department (970-565-3056) <https://montezumacounty.org/public-health/>

\*Vendors will provide their own tents, shades, awnings, tables and chairs, signs, cords etc. These items must be secure and tied down with sandbags so that they do not cause injury or damage.

\*All vendors using liquefied gas products for their activities shall be required to have a first aid kit and a 5lb fire extinguisher at their booth.

\*The sale of articles considered potentially harmful or dangerous to the health, comfort or safety of participants is prohibited. Vendors attempting to sell any of these items will be asked to leave without refund.

\*Security will not be provided. Secure your booths overnight. You may also camp overnight if you feel necessary. Please keep your booth areas clean and free of trash.

\*No vendor parking on Grand Avenue per CDOT rules. We will designate parking.

\*All vendors must check in on Thursday BEFORE setting up. Check in starts at 12:00pm

\* No unloading in the parking lot after 8:00am Friday

\* No driving over cords or through the grass
